# MEMORANDUM OF UNDERSTANDING BETWEEN

# THE BOLIVIAN INSTITUTE OF STANDARDIZATION AND QUALITY (EL INSTITUTO BOLIVIANO DE NORMALIZACIÓN Y CALIDAD)

#### AND

### THE AMERICAN NATIONAL STANDARDS INSTITUTE

The Bolivian Institute of Standardization and Quality (IBNORCA) and the American National Standards Institute (ANSI):

Recognizing the desirability of the global use of international standards;

Committed to ensuring that their national standards and their application facilitate international trade;

Pledging to facilitate cooperation between IBNORCA and ANSI to that end;

Hereby endorse the following articles of this MOU concerning matters covering standardization, conformity assessment and the mutual exchange of information and publications between the respective organizations.

#### Article 1

# IBNORCA and ANSI agree to:

- (1) exchange views on the activity and operations and program of work of various international and regional standardization and conformity assessment organizations, including but not limited to the International Organization for Standardization (ISO), the International Electrotechnical Commission (IEC) and the Pan American Standards Commission (COPANT).
- (2) share each other's views and, where feasible, work to develop mutually supportive positions relating to the role of those organizations to their respective members.

#### Article 2

## IBNORCA and ANSI agree to:

- (1) facilitate dialogue among Bolivian and US experts in various areas of standardization and conformity assessment as determined by special arrangements between the parties;
- (2) encourage standards organizations in their countries to identify their counterpart groups for the purpose of establishing bilateral relationships, including mutual exchange of information and materials, trade shows/exhibits, and possible joint business ventures, to stimulate industry-toindustry cooperation as a building block to international standardization and free trade;
- (3) arrange exchange of visits of the senior management of IBNORCA and ANSI; and

(4) explore organizing and sponsoring conferences, workshops technical symposia on standardization and conformity assessment subjects of mutual interest.

#### Article 3

IBNORCA and ANSI agree to exchange, using all appropriate media:

- current catalogues of their national standards and procedures published by the respective organizations;
- general information and publications on conformity assessment (including certification, (2) suppliers declaration and accreditation) published by the respective organizations;
- general materials for training courses on standardization and conformity assessment developed (3) and published by the respective organizations; and
- periodical publications and other relevant information published by the respective organizations. (4) Further to this item, IBNORCA is given ANSI's permission to translate and reprint free of charge any articles in any edition of the ANSI Reporter.

#### Article 4

Any issues arising from the interpretation or implementation of this MOU will be settled through consultations between IBNORCA and ANSI or such other means as they may mutually decide.

#### Article 5

- (1) This MOU can be amended by the written agreement of both parties.
- This MOU is valid until terminated. Either Party may terminate this MOU by providing the (2) other party with a written notice.
- Notice to terminate or amend the MOU shall not retroactively change the terms of any existing project or program being undertaken by the parties for the specific term of the project or program without consent of both parties.
