Several industries and a number of government agencies already require ANSI accredited certifications for their new hires—and many are considering similar requirements for certificates. Among those that have sought ANSI accreditation for their certificate programs are the U.S. Army, Food and Drug Administration, the Federal Bureau of Investigation, the National Association of State Boating Law Administrators, Sullivan University, and SCIPP International.

ANSI-CAP is based on an American National Standard, ASTM E2659-09, *Standard Practice for Certificate Programs*. The standard requires that your program meets predefined industry requirements for content, follows predetermined processes, includes constant feedback for quality improvement, and much more. ANSI's accreditation process itself follows ISO/IEC 17011, the International Standard that defines quality third-party accreditation practices.

ANSI accreditation will signify that the certificate holder has completed a prescribed course of study designed specifically to meet predefined industry requirements—and that your organization has met, and continues to meet, standards for quality improvement. Will your competitors be able to say the same?

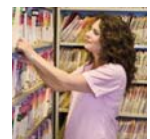
