American National Standards Maintained Under Continuous Maintenance

The ANSI Procedures for the Development and Coordination of American National Standards (ANSI Procedures) provide two options for the maintenance of American National Standards (ANS): periodic maintenance (see clause 4.4.1) and continuous maintenance (see clause 4.4.2). Continuous maintenance is defined as follows:

The standard shall be maintained by an accredited standards developer. A documented program for periodic publication of revisions shall be established by the standards developer. Processing of these revisions shall be in accordance with these procedures. The published standard shall include a clear statement of the intent to consider requests for change and information on the submittal of such requests. Procedures shall be established for timely, documented consensus action on each request for change and no portion of the standard shall be excluded from the revision process. In the event that no revisions are issued for a period of four years, action to reaffirm or withdraw the standard shall be taken in accordance with 4.4.1 and 4.4.3.

The Executive Standards Council (ExSC) has determined that for standards maintained under the Continuous Maintenance option, separate PINS announcements are not required. The following ANSI Accredited Standards Developers have formally registered standards under the Continuous Maintenance option.

A challenge is initiated when a letter from an interested entity is received by the Registration Coordinator. The letter shall identify the alphanumeric organization name being challenged and state the rationale supporting the challenge. A challenge fee shall accompany the letter. After receipt of the challenge, the alphanumeric organization name shall be marked as challenged in the Public Review list. The Registration Coordinator shall take no further action to register the challenged name until the challenge is resolved among the disputing parties.

Proposed Foreign Government Regulations

Call for Comment

U.S. manufacturers, exporters, regulatory agencies and standards developing organizations may be interested in proposed foreign technical regulations issued by members of the World Trade Organization (WTO). In accordance with the WTO Agreement on Technical Barriers to Trade (TBT Agreement), members are required to report proposed technical regulations that may significantly affect trade to the WTO Secretariat in Geneva, Switzerland, who in turn disseminates the information to all WTO members. The purpose of this requirement is to provide trading partners with an opportunity to review and comment on the regulation before it becomes final.

To distribute information on these proposed foreign technical regulations, the National Center for Standards and Certification Information

(NCSCI), National Institute of Standards and Technology (NIST), provides an on-line service - Export Alert! - that allows interested parties to register and obtain notifications, via e-mail, for countries and industry sectors of interest to them. NCSCI serves as the U.S. WTO TBT inquiry point and receives copies of all notifications, in English, to disseminate to U.S. industry. PROPOSED REQUIREMENTS FOR THE FIFTH EDITION OF THE STANDARD FOR DOOR, DRAPERY, GATE, LOUVER, AND WINDOW OPERATORS AND SYSTEMS, UL 325.

For your convenience in review, proposed additions to the previously proposed requirements are shown underlined and proposed deletions are shown lined-out.

1. STOPPED, PARTIALLY OPEN GARAGE DOOR

PROPOSAL

56.5.1 The user instructions shall include the following or equivalent text:

IMPORTANT SAFETY INSTRUCTIONS

WARNING – To reduce the risk of severe injury or death:

- 1. READ AND FOLLOW ALL INSTRUCTIONS.
- 2. Never let children operate or play with door controls. Keep the remote control away from children.
- 3. Always keep the moving door in sight and away from people and objects until it is completely closed. NO ONE SHOULD CROSS THE PATH OF THE MOVING DOOR.

4. NEVER GO UNDER A STOPPED, PARTIALLY OPEN DOOR.

- 4.5. Test door opener monthly. The garage door MUST reverse on contact with a 1-1/2 inch high object (or a 2 by 4 board laid flat) on the floor. After adjusting either the force or the limit of travel, retest the door opener. Failure to adjust the opener properly increases the risk of severe injury or death.
- 5.6. For products having an emergency release, when possible, use the emergency release only when the door is closed. Use caution when using this release with the door open. Weak or broken springs are capable of increasing the rate of door closure and increasing the risk of severe injury or death.
- 6.7. KEEP GARAGE DOORS PROPERLY BALANCED. See owner's manual. An improperly balanced door increases the risk of severe injury or death. Have a qualified service person make repairs to cables, spring assemblies, and other hardware.
- 7.8. SAVE THESE INSTRUCTIONS.
