17.	Other Comments				
1.	Major plenary issues for the US were: The US compromised and supported a proposal to establish a Maintenance Team (MT) for IEC 62474, since the IEC Central Office said a WG can only create a document, not review or update documents. The first task of the MT is to submit a Review Report (RR) with recommendations for what, if any, updates for IEC 62474. The US supported Canada and other NCs that stated it is important to announce MT 62474 as a normal process to prevent delay in its adoption. The US retains the convenorship, as WG1 experts were autmatically named as MT 62474 experts. When the MT 62474 convenor from the US steps down in 2015, the US should be allowed to nominate a new convenor or co-convenors.				
2.3.	The US succeeded to disband WG4 and to have Japan NC distribute a proposal for next tasks consistent with the strategic business plan. IEC rules for WG and PT convenors was changed to limit to three 3-year terms, where TC111

must approve convenors for each term. TC111 will make a decision on this starting with the

- participating National Committee on VT62474, that it either participate/respond or will be removed from VT62474. This was supported by the US.
- 5. The US suceeded in obtaining the TC111 Plenary agreement for AHG11 Marketing to continue implementing its plan for one more year as described at the plenary.
- 6. A US concern regarding the ability to limit changes to IEC 62430 in a Joint IEC/ISO environmentally conscious design standard remains, as comments from ISO 207 experts indicated a wish from several to significantly add to scope. The US needs to continue to engage on this issue. Joint US collaboration between IEC TC111 and ISO 207 would be very beneficial to ensure alignment of positons.
- 7. The assigned number for the joint ISO/IEC environmentally conscious design (ECD) standard is IEC 62959. More discussion is needed whether to request a change to this number based on what the document's audience understands (e.g., IEC 62430 vs ISO TR 14062).
- 8. A decision on whether PT 62824 will be disbanded was delayed until more is known about the progress of the JWG for ECD. This was acceptable result for the US.
- 9. The US succeeded to have the plenary agree to continue the work of some type of team to help the TC111 officers to update the strategic business plan. A questionnaire will be sent to NCs asking to create a task force for this purpose, using the screening process developed by AHG10. The US succeeded to leep the screening process included in the proposal, which the US strongly supports.

Decision 12/06:

TC 111 agrees to nominate as IEC TC 111 liaison person with ISO TC 207 WG 10 Professor Kun-Mo Lee (Korea)

Decision 12/07:

TC 111 agrees the following joint WG "ECD" convenorship and co-convenorship tasks: Convenor: Dr. Shu Yamada

Administrative responsibility for the project as an IEC-lead JWG with ISO

- record and manage the project as in the programme of work
- ensure that the comments and votes at all stages of the project are compiled and handled appropriately
- prepare drafts for the committee, enquiry and approval stages according to procedures

Co-Convenor: Mr. Daniel Trillos

Collaborate with Convenor for the efficient work of JWG

Responsibility for the ISO side to

• ensure that at ISO side the comments and votes at all stages of the project are compiled and handled appropriately

TC 111 notes that relating to the JWG "ECD" project in preparation TC 111 goes for having only one ECD related document shared by ISO and IEC

Decision 12/08:

TC 111 decides to circulate a questionnaire (yes or no questions) to the NCs, 2 months for answers, asking for:

- the creation of a Task Force (TF) helping the TC 111 Officers to maintain the Strategic Business Plan (SBP) with the task to propose update to the SBP, taking into account the screening process developed by AHG 10 (attached to the questionnaire)

The existence of the group will be confirmed or reviewed in case of necessity

If approved by the majority of the NCs answering, the TF will be established and the TF Convenor will be the existing AHG 10 convenor.

The NCs will be invited to provide members

Decision 12/09:

TC 111 decides to disband AHG 10

TC 111 agrees that TC 111 officers in collaboration with WGs/PTs Convenors will update the program of work

Decision 12/11:

TC 111 approves the establishment of liaison with TC 105 and approves that TC 111 Liaison person is Mrs. Chie Uchiyama

Decision 12/12:

TC 111 agrees that TC 111 Officers will circulate an INF document regarding the current liaison status of TC 111

Decision 12/13:

TC 111 agrees a procedure to approve liaison request with the circulation of a questionnaire (6 weeks for answer) for a formal voting by balloting

TC 111 confirms the acceptance of invitation of SWEDISH NC to host the next 2015 IEC
