1. Call to Order and Introductions (Timothy T Duffy, Chairman, Rockwell Automation)

The meeting was called to order by Chair Tim Duffy at 9:00 a.m. (EDT). He welcomed everyone to AAMI and thanked them for attending this CAPCC meeting. He expressed his appreciation to AAMI and particularly to Carol Herman and Hae Choe for their help and hospitality in arranging for this series of USNC meetings. Mr Steve Campbell, Chief Operations Officer, AAMI, welcomed the participants, wished them a successful meeting, and Carol Herman provided logistical information for the day's event.

Mr Duffy voice a special welcome to Dr Ulrich Spindler, IEC Vice President and CAB Chair, and expressed his appreciation for his taking the time to be with CAPCC today.

This was followed by self-introductions.

1.1 Approval of the Draft Agenda

Mr Duffy called attention to the Preliminary Agenda for today's meeting and invited suggestions for additions and none were suggested. The Draft Agenda (USNC CAPCC 138A) was considered approved as circulated.

1.2 Approval of the Minutes – Meeting/Teleconference – 19 May 2015

The Chair called attention to the Minutes of the 19 May 2015 meeting (USNC/CAPCC 136) held at UL in Research Triangle Park, NC, and noted that the following correction was submitted by Mr Jonathan Colb.

3.1 Report by Joan Sterling – Liaison ANSI Conformity Assessment Policy Committee (CAPC)

Ms Sterling reported that the last meeting of the ANSI Conformity Assessment Policy Committee (CAPC) was held on 5 June 2015. The next meeting is scheduled for Thursday, 1 October, during World Standards Week and in conjunction with a meeting of the ANSI National Policy Committee (NPC).

3.2 Report by Tim Duffy – Liaison ANSI International Conformity Assessment Committee (ICAC)

The Chair called attention to document CAPCC 140 (ATTACHMENT B) and provided a brief report on the CASCO documents that have been processed to the ANSI International Conformity Assessment Committee (ICAC).

3.3 Report on CASCO - Lane Hallenbeck, ANSI Vice President, Accreditation Services and Chair, CASCO

Mr Hallenbeck provided a brief report on the ISO Committee on Conformity Assessment (CASCO) and highlighted the following:

- Mr Frank Makamo of the South African Bureau of Standards (SABS) was scheduled to become CASCO Chair at the end of 2015, term 2016 2017.
- Discussed the subject of a "needs assessment" for CASCO New Work Items.

4. Status Report on USNC's Response to the Goals Set by the ANSI Board Task Group on Cost Recovery, Philip M Piqueira, USNC President

Mr Piqueira highlighted the work of the ANSI Board Task Group on Cost Recovery and called attention to the most recent actions of the USNC Finance Committee. Four meetings/teleconferences have been held to-date and all options are being explored. While much progress has been made, the Committee is not yet ready to recommend a funding approach to the USNC Council. Meetings will continue and the January 2016 Council meeting is targeted for presentation and discussion of the Finance Committee's recommendations. (USNC/Council 672) (ATTACHMENT C)

From the CAPCC side, Mr Duffy noted that the Committee still needs an analysis of the resources that are utilizes and a funding mechanism. Mr Margis has developed a spreadsheet that CAPCC will further analyze to determine the Conformity Assessment share of the USNC budget. The proposed 2016 USNC budget will be reviewed so that numbers can be plugged into the spreadsheet for a better understanding of the financial impact.

5. Presentation by Dr Ulrich Spindler, Eaton Corp, IEC Vice President and Chair, IEC Conformity Assessment Board (CAB)

Mr Duffy introduced Dr Spindler and welcomed him to the US, to AAMI and to the CAPCC. Dr Spindler dialogued with CAPCC about CAB, its structure, activities and future challenges. He reviewed some of the initiatives underway in the CAB and at the IEC relative to conformity assessment. He shared his vision on the future of global CA for the benefit of industry and its customers. He also remind the Committee of the close links in standardization as well as CA that have existed between himself and the USNC in the past during his years as President of CENELEC. Dr Spindler highlighted the following:

USNC/IECQ – received a report noting some new work areas including E-Labeling (ECCC gained IECQ approval). Also working on getting the latest Operating Procedures finalized and reviewed by the Subcommittee on Operating Procedures.

7. USNC CAPCC Subcommittee on Operating Procedures of the USNC Conformity Assessment Systems

Mr Margis reminded the Committee that the revised Draft Terms of Reference of the CAPCC Subcommittee on Operating Procedures of USNC Conformity Assessment Systems were approved at the 19 May 2015 meeting at UL in Research Triangle Park, NC. He reported that efforts are underway to obtain current versions of the Operating Procedures of each of the 4 Systems which, when in hand, will be circulated to the Subcommittee for review and approval.

He reported that the latest versions of the USNC/IECEE, USNC/IECEx and USNC/IECRE operating procedures have been received and the USNC/IECQ Procedures are expected shortly. It is anticipated that a teleconference will be held to review these procedures and that this will be followed by a face to face in January 2016 possibly in conjunction with the USNC meetings. This face to face review is also include an analysis of existing USNC IEC governance documents

related to USNC IEC CA..

Mr Margis called attention to the following request from the USNC/IECEx Secretary concerning this System's current Procedures:

"The USNC/IECEx asks the CAPCC Policy Committee to endorse the proposed revision to its Rules of Procedure for consideration by CAPCC. The revision was made at its August 10-11, 2015 meeting to address quorum determination at committee meetings. The committee consists of twenty-four (24) voting members, with seventeen (17) members present, in person or by phone, constituting a quorum to conduct business. The number of affirmative votes necessary for approving the revision at a duly constituted meeting is two-thirds of the members present and voting. The voting results are as follows: (17, 0, 0). Based on the vote result, the revised rules of procedure were approved by the committee.

The changes are as follows:

- Section 2.2.5 renumbered as 2.2.6.
- Deleted sentence addressing a change to a membership status from voting to observer for not attending three consecutive meeting.
- Added a new 2.2.5 to address change in voting status for failure to attend three consecutive meetings."

It was moved, seconded and

- VOTED #1 To endorse the proposed revision of the USNC/IECEx Rules of Procedures as presented for CAPCC's consideration at its 22 September 2015 meeting.

- 8. Occupational Safety and Health Administration Kevin Robinson, Senior Electrical Engineer & NRTL Program Lead Assessor, U S Department of Labor, OSHA

Mr Robinson was not able to participate in this CAPCC meeting. However, he provided an update on the status of the happenings in the NRTL Program. The following report was read to the participants:

"The OSHA NRTL Directive update has been completed and is currently undergoing review within OSHA. OSHA anticipates the draft directive will be published in the Federal Register before the end of the year. The directive will be open for public comment for 60 days. We currently have no stakeholder's meeting planned, although based on the comments we receive from the directive public comment period, we will consider holding a meeting after the comment period closes. From the technical perspective, the current draft is very similar to the partial draft that was released in August 2014. 9. Follow-up Discussion on Medical Device Conformity Assessment Issues – Jianchao Zeng, Ph.D., Electrical Engineer/Senior Standards Advisor, CDRH Standards Program, U S Food and Drug Administration

Dr Zeng provided an up-date on the Conformity Assessment issues of interest to the FDA that he highlighted during the May 2015 meeting at UL in RTP, NC. Dr Zeng discussed the use of Declaration of Conformity to FDA recognized standards for compliance. Possible shift toward OSHA/CPSC model and outreach to NIST for collaboration. He highlighted the CA internal discussions taking place in FDA at the present time and agreed to keep the Committee advised of developments. (ATTACHMENT I)

10. Status Report on the USNC CAPCC Regulatory Labeling Working Group - Gary Schrempp, Dell, Inc.

Mr Schrempp provided a brief status report on the USNC CAPCC Regulatory Labeling Working Group. Efforts on the part of ITI, TIA and NEMA were noted. 12. Report on the Last CAB Meeting – 15 June 2015, Geneva, Switzerland

12.1 List of Decisions

Mr Duffy called attention to the List of Decisions from the 15 June 2015 CAB meeting in Geneva (CAB/1400/DL) and highlighted the most significant items.

- CAB Agendas are now operating with a Consent Agenda similar to the format used successfully by the SMB. During discussion, Mr Jonathan Colby expressed some reservations about the use of a Consent Agenda.
- Decision 37/3 Vademecum CAB created a Task Force to continue work on the Vademecum
- Decision 37-4 Edison Award Criteria Mr Duffy requested by CAB to draft new criteria for the Edison Award that are more representative of the CAB's structure and operations.
- Decision 37-5 CAB WG Membership Mr Duffy called attention to the current list of USNC Experts on CAB Working Groups. (USNC/CAPCC 141) (ATTACHMENT L)
- Decision 37-7 Peer Assessment Commonalities CAB supported continued investigation of peer assessment for becoming an element of a future IEC CA toolbox.
- Decision 37-8 CAB Policy Regarding Peer Assessment CAB tasked WG 10 with strengthening the language concerning peer assessment in the CAB Policy document with consideration to referencing ISO/IEC 17040.
- Decision 37-9 USNC Peer Assessment Proposal CAB tasked WG 11 to use CAB/1379/INF as a basis to perform an operational review of IEC CA Systems'

implementation of peer assessment with the goal of ensuring its conformance with CAB Policy, seek harmonization where possible and to submit a report of its findings and recommendations. The CA Systems were requested to contribute to the WG11 results.

- Decision 37-11 ITU Collaboration on Interoperability CA CAB stated its strong support for continued cooperation with ITU.
- Decision 37-14 CAB WG 10 on Policy and Strategy Considered and acted on 8 Recommendations submitted by WG 10.
- Decision 37-17 WG 11 New Convener Mr Duffy is now the Convener of WG 11
- Decision 37-20 Draft Rules for IEC Systems-Approach to CA and a CA Framework To be used for identifying market needs for systems and other CA services.
- Decision 37-21 CAB WG 17 Cyber Security CAB noted that WG 17's scope is focused on home automation, smart devices (such as smart meters) and medical devices and indicated that WG 17 should focus on all those sectors concerned with cyber security except those currently being worked on in IECEE (Industrial Automation).
- Decision 37-22 IECQ Treasurer Appointment Mr Wynn Bowman was appointed IECQ Treasurer.

12.2 Nominations of Conformity Assessment Officers for the 2015 IEC Thomas A Edison Awards – CA

Mr Duffy also called attention to the IEC Thomas A Edison Award – Conformity Assessment (AC/8/2015) and noted that the deadline for nominations was 15 May. Again, this year the USNC failed to come up with appropriate nominations and one reason is felt to be the criterion that "Persons serving or having serves as IEC Officers, IEC employed staff, SMB members or CAB voting members shall not be eligible." This is felt to exclude well qualified people who may have served on CAB in the past. The USNC is looking to expand the limited pool of Experts that are eligible. It was agreed that the USNC should consider submitting a proposal to have this item addressed. (General Secretary's Note: Mr Duffy raised this issue at the June CAB meeting.)

After discussion, CAPCC discussed the subject of which candidates the USNC should support and selected two for recommendation to the USNC President.

14. Conformity Assessment Issues in the Americas, Paul A Moliski, Intertek, and Chair, ANSI Regional Standing Committee - Americas

Mr Moliski, Chair of the ANSI RSC-Americas, provided a brief report on conformity assessment issues in the Americas. (ATTACHMENT M) He highlighted the following:

- Ecuador adding many new regulations including requirements for foreign testing to standards mostly trade balance
- Brazil now allowing IECEE for IT equipment
- Mexico IT and telecom standards being updated
- Colombia dynamic CA landscape for safety and energy efficiency

15. Status Report on Conformity Assessment Issues Related to India (Robert W Griffin, IBM)

Mr Griffin, TA for the USNC TAG for IEC/TC 108, called into the meeting to provide a brief up-date report on India's certification requirements. Two major changes include:

- Market Surveillance Requirements under development by DEITY.
- Amended BIS Consumer Safety Law (language this summer) could have significant impact.

16. Dialogue with Mitchell A Guthrie, International Chair, IEC/TC 81 – Lightning Protection and Technical Advisor, USNC TAG for IEC/TC 81

Mr Guthrie discussed international conformity assessment challenges in the area of IEC TC 81 - Lightning Protection. As IEC TC 81 documents progress through maintenance cycles, issues associated with conformity assessment arise in both the components standards (IEC 62561 series) and application standards (IEC 62305 series). For IEC 62561 standards the primary issues are associated with how to ensure that the components passing the type tests required by the standards continue to be manufactured with the same methods and materials which passed the tests. In IEC 62305 documents the primary issues are associated with the qualifications of people performing the various tasks required for the design, installation, and inspection of lightning protection systems. In comparing the conformity assessment needs of the industry, it does not appear that any of the existing IEC Conformity Assessment Systems fit the lightning protection application although there are strong parallels in some such as IEC EX and IEC RE. (ATTACHMENT O)

A Q & A Period followed Mr Guthrie's presentation and it was agreed that the dialogue on this subject would continue.

17. Status Report on US Government Activities Related to Conformity Assessment (Amy Phelps, Computer Scientist/Conformity Assessment Advisor, Standards Coordination Office, NIST)

Ms Phelps left the meeting early but submitted the following report via E-Mail subsequently.

"There is not a lot to update the CAPCC regarding government activities. The one item that may be of interest to the group is regarding the OMB circular A119 update.

At ANSI World Standards Week next week, OMB will be providing an update of the revisions to Circular A119 during the Interagency Committee on Standards Policy (ICSP)/ Government Member Forum Meeting (GMF). This meeting will be held on Wednesday, 9/30, and is an open meeting. Below is brief background information for those that may be unfamiliar with Circular A119.

OMB Circular A-119 - Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities

The policies of OMB Circular A-119 are intended to: (1) encourage federal agencies to benefit from the expertise of the private sector; (2) promote federal agency participation in such bodies to ensure creation of standards that are useable by federal agencies; and (3) reduce reliance on government-unique standards where an existing voluntary standard would suffice.

Please let me know if you have any questions or need additional information."

18. Issues Raised by the CAPCC Membership

The CAPCC membership was invited to submit questions or issues that are recommended for discussion and consideration by the Committee. No suggestions were raised for this meeting.

19. FINCA (Forum of the IEC National Committees of the Americas) (Argentina, Brazil, Canada, Chile, Columbia, Mexico and USA)

Mr Piqueira reported that the 3 – 4 September 2015 FINCA meeting held in Cartagena, Colombia. The meeting was well run and a great many issues were address. Of particular note was the scheduling of Breakout Session to discuss, in detail, a number of issues. This session proved to be very successful and beneficial. The 2016 FINCA meeting is scheduled for Argentina.

CAPCC could develop the questions to be address and this might be of interest to both IEC and the USNC.

21. Next CAPCC Meeting/Teleconference

Mr Zegers reported that the next CAPCC Meeting is tentatively scheduled for Tuesday, 12 January 2016 in conjunction with the next TMC and Council meetings to be held at Sony Electronics in San Diego, CA. Discussions are underway to confirm this date and location in the very near future.

22. Adjournment

Mr Duffy reminded the Committee that we are always looking for suggested agenda topics for future meetings. Please don't hesitate to let the Officers know if there are topics that you would like to see on a future CAPCC agenda.

He expressed his appreciation to all participants for their contributions and particularly to Carol Herman, Hae Choe and to AAMI and its Staff for their efforts on our behalf.
