Availability of Published IEC Standards

USNC Technical Advisors, Deputy Technical Advisors and TAG Secretaries have the right to request of the USNC Staff gratis, watermarked copies of newly published IEC standards under the jurisdiction of their TC/SCs.

When you see a published standard under your TC/SC's jurisdiction request a copy from Mr. Kevin Sullivan, USNC Program Administrator at <u>ksullivan@ansi.org</u> (Tel: 212-642-4963). The document will be sent to you as a pdf file or if the request is for multiple files they will be posted on the ANSI Website in a password protected area.

If your TAG is considering the adoption or adaptation of an IEC Standard and you must request authorization from the USNC General Secretary, Tony Zertuche (Tel: 212 642 4892 E-Mail (<u>tzerutche@ansi.org</u>) in accordance with the related USNC Policy and, if you require a revisable copy for this purpose, one can be provided..

Upon receipt of the standard we request to notify your TAG participants that the standards are now available and how they can be ordered electronically from the ANSI Electronic Standards Store at <u>http://webstore.ansi.org/</u>. As USNC TA/DTA and TAG Secretary, you are receiving this complimentary copy to be retained by the TAG Secretary for use by the TAG in accordance with the approved maintenance cycle of the document(s) and as a reference document when participating in related IEC standards development activities.

Please be aware that IEC International Standards are copyrighted documents. If it becomes necessary to reproduce a copy of any IEC International Standard for the purposes described above, please notify the USNC Office and affix a notation to the cover of the document, or include an appropriate notification, reproducing the following statement:
