Promoting Standards and Technology Cooperation



Through its U.S.-Indo-Pacific Standards and Technology Cooperation Program (STCP), the U.S. Trade and Development Agency is supporting Vietnam's efforts in leading adoption and implementation of 5G standards. This workshop will offer participants the opportunity to engage with key Vietnamese and U.S. 5G public officials and industry experts to share solutions to meet growing 5G demand while addressing security needs and promoting market openness, an enabling regulatory environment, and industry best practices.

BACKGROUND

Vietnam has one of the fastest growing digital economies in the Southeast Asia region, acting as a frontrunner and early adapter of 5G networks. Global standards and recognition of international best practices will be vital to coordinate 5G efforts across the region, as well as to facilitate an open regulatory environment for utilizing 5G wireless capabilities in vertical industries. This workshop, organized in partnership with the Ministry of Information and Communications (MIC), will allow Vietnamese and U.S. stakeholders to discuss the importance of 5G standards to facilitate trade and investment cooperation.

The objectives of the 5G Standards Workshop are to:

- Highlight innovations from industry-driven standards development
- Share experiences in 5G implementation and development
- Promote best practices for regulation and compliance
- Feature 5G technologies and services

Key participants will include government officials from the MIC, as well as leading U.S. government officials and industry experts. Speakers from the Vietnamese government and private sector will also provide important context and updates on the current state-of-play and engage in substantive discussion throughout the program.
