

A Virtuous Cycle



Ratings for all buildings

When performance is measured, performance improves. When performance is measured and reported back, the rate of improvement accelerates.

Efficiency of existing building stock continuously improves

Ratings disclosed to market

Owners improve efficiency to help competitiveness

Market compares building performance

Market rewards energy-efficient property with more business One result: Exceptionally cost-effective peak load reductions

Rating Laws: International Timeline





requires energy certification for homes and buildings

2004: Norway,

part of the European Economic Area, formally agrees to implement the **EPBD** and building certification requirements





2007: Brazil adopts voluntary building rating regulations that become mandatory in 2012



2010: EPBD Recast

The FPBD is recast to strengthen the energy performance requirements for all EU Member States and to clarify and streamline provisions from the original Directive

Energy Performance of Buildings Directive

(EPBD) EU Member States are required to establish mandatory energy certification schemes for all homes and buildings



2008: China

2008: Turkey

adopts a mandatory certification scheme




2010: Australia

passes the Building **Energy Efficiency** Disclosure Act requiring energy performance disclosure for commercial buildings at point of sale or lease








Policy Impact Projections

Annual Policy Impact Projection on Number of Buildings by Jurisdiction


- Approximately 4 billion square feet

- Delivers energy performance metrics based on utility data
- Supported by the EPA
 - Trainings and materials, as well as direct support
 - Automated Benchmarking System
 - Customized reporting forms for jurisdictions with mandates




Energy Star Buildings Command Market Premiums




Added Value of ENERGY STAR-Labeled Commercial Buildings in the U.S. Market











