

Stakeholder Views

OASIS

- Easy to join and participate
- New Committees initiated by member request
- Very open and auditable process
- Very nimble process
- Published Standards available free on the web
- Optional to be ad-hoc or continue through version improvements
- de-Facto Standard (OK for some consumers in some situation)

□ ISO/ITU

- More formal delegate process
- New work vetted by oversight
- More formal process
- Nominal fee for published Standards
- Formal life cycle postacceptance
- de Juere Standard (necessary for some consumers in some situations)



OASIS Developers

- □ OASIS has 5500+ participants representing ~375
 companies, organizations, agencies in 100 countries
- OASIS is low barrier to entry and participation
 - Individuals, employees and representatives
 - Agree to play by the rules, pay the dues
- Join when they need to work on a project, need not make long term commitment. Developing Standards need not be a career.




Consumers of OASIS Standards

- Many of the OASIS Standards participants do so out of self interest they intend to use the Standard
 - 50% of the 5500 OASIS participants are users, implementers and influencers
 - The technologists are developing Standards for their use
- Whole industry sectors and communities build around OASIS Standards – without becoming members
- □ OASIS Standards are identified best-practices or implementation requirements of many governments, agencies, industry associations, etc
- Hard to know how many implementations because Standards are free on the Web



So why advance OASIS Standards to ISO, ITU and others?



- □ To validate the Standard though another set of developers
- □ To reduce duplication of effort and multiple Standards
- To make the results available to another set of consumers
- □ To meet more Standards stakeholders' needs



Recent Examplesdifferent motive forces

- □ ISO/TC 154, TS 15000 (ebXML)
- ISO/IEC JTC1 International Standard 26300 (OpenDocument)
- ITU-T Recommendations from SG-17
 - X.1141 (SAML)
 - _ X.1142 (XACML)



ebXML One Standard- Many stakeholders' needs met

- Joint project OASIS and UN ECE-CEFACT 1999-2001
- ebXML 2.0 (CPPA, MS, RS, RIM) OASIS Standards 2002
- \blacksquare ebXML 2.0 \rightarrow ISO TS 15000 2004
- UN CEFACT submitted CCTS to ISO 2004
- ebXML 3.0 development in progress RS, RIM OASIS Standards 2005 these include Federated Registry



Benefits of Sharing Standards

- Speed, broad participation and openness of de-Facto Standards
- Critical review and stability of de Juere Standards
- □ Shares developers resources, reduces duplicate efforts
- □ Serves the greatest number of consumers
- □ At the end of the day, one Standard is better than two!
