SUBMISSIONS

Eligibility

Nominations for the ANSI 2003 Annual Awards Ceremony may be submitted by any member of the Institute or its boards, councils, committees, and other groups. Any member of the U.S. voluntary consensus standardization and conformity assessment community, with the exception of current members of the ANSI Board of Directors Awards Committee, is considered eligible.

Nominations

All nominations must include the following information:

- Identification of the award for which the individual is being nominated;
- Name of nominee, current title, and contact information (including business address, telephone, fax, and e-mail);
- Information on the nominee's professional career;
- A summary of the nominee's participation in and contribution to organizations engaged in standardization, certification, or measurement (including positions held and accomplishments);
- A 100- to 200-word statement of the individual's eligibility for the award for which he or she is being nominated (see award descriptions for more information);
- A statement from the sponsor, suitable for quotation in the nominee's biography to the Awards Committee, regarding one or more specific accomplishments;
- A statement of the sponsor's authority to make the nomination, particularly if the nomination is on behalf of a committee or organization;
- A statement regarding the availability of the sponsor, or the sponsor's designee, to participate in the presentation of awards on Wednesday evening, October 1, 2003 in Washington, DC.
- Sponsor's name, title, organization, contact information, and signature.

Deadline

All nominations must be received by ANSI no later than <u>Friday</u>, July 11, 2003 (5:00 p.m. Eastern). Late submissions will be considered solely at the discretion of the Awards Committee.





SELECTION PROCESS



The ANSI Awards Committee, consisting of the Chairman, Immediate Past-Chairman, and the current Vice-Chairmen of the Board of Directors, will consider the nominations received for each of the five medals, the President's Award for Journalism and the Meritorious Service Award.

Selections are made based on the comparison of data submitted against the description of each award.

An announcement of the 2003 recipients will be made in the late summer and will allow adequate notification to the award recipient and his or her nominator prior to the presentation ceremony.

S election Process (continued)

- If, in the judgment of the Awards Committee, no candidates meet the eligibility requirements, an award may not be given;
- The Awards Committee reserves the right to present a nominee with an award other than the one for which he or she was nominated;
- Only one medal per year will be awarded in each classification; multiple recipients or groups may be named for the meritorious service award;
- Nominations of candidates not selected for awards may be resubmitted in a subsequent year for consideration;
- Each final nominee, selected in accordance with these procedures, will be requested to provide additional biographical information and must indicate his or her willingness to accept the award at the October 1, 2003 banquet and presentation ceremony.

All nominations must be received by ANSI no later than <u>Friday</u>, <u>July 11, 2003</u> (5:00 p.m. Eastern). Late submissions will be considered solely at the discretion of the Awards Committee.
