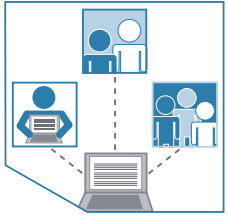

### Pricing

The fee for a Site License is determined by the:

1. specific standard(s)\* or collections of standards selected;
2. number of locations accessing the standards; and
3. number of employees accessing the standards.

\*ANSI members receive additional discounts on select standards

### Standards for Single-Use (webstore.ansi.org)

Sometimes access to a standard is not needed across an entire organization. In those cases, ANSI's eStandards Store (eSS) is the resource that will complement the Site License model.

The eSS provides users with instantaneous access to nearly 175,000 standards and technical documents from around the world. Standards on the eSS can be purchased for individual use and the download completed within moments. All transactions are conducted via a secure server equipped with the latest encryption technology to safeguard online purchases.
