INVITATION

TO PARTICIPATE IN THE INTERNATIONAL WORKSHOP AGREEMENT ON DEFINING PROFESSIONAL FARMER ORGANIZATIONS

The ISO (International Organization for Standardization) has approved the request from NEN (Dutch Standardization Institute) to develop a formalized definition for professional farmer organizations. This invitation requests your engagement in this process.

The current context for global agriculture to grow and thrive – high rates of population growth, challenges around low income, and inconsistent access to finance, means that change is essential. These challenges are compounded by the current fragmented approach to building farmers' business management capacity, and a disconnect with market opportunities, buyers, banks and input providers.

In the instance where farmer organizations lack the resources, knowledge and experience to compete in dynamic international agricultural markets, having the resources to engage as professional businesses with increased business acumen, access to finance, and other resources, can be transformational.

A consensus based definition for professional farmer organizations will provide market actors, capacity builders, investors, donors, commodity certification schemes and regulators with a common language and understanding around required capacities of farmer organizations and needs for improvement. The definition is meant to determine whether farmer organizations are ready for business engagement or not.

AMEA (the Agribusiness Markets Ecosystem Alliance) approached NEN to start an International Workshop Agreement (IWA) and develop such a definition. AMEA is a global multi-stakeholder alliance of diverse organizations sharing a belief in the collective and transformative power of farming as a business and increasing the professionalism of farming organizations. AMEA provides a common language and framework for all stakeholders to work together in a more effective and efficient way.

NEN will facilitate the standards development process as a neutral partner. An IWA is a type of document that is developed with direct participation of stakeholders outside the traditional ISO country representation system. It is developed within one year and includes opportunities for significant testing and recalibration. AMEA has chosen for an independent-led IWA process to develop this definition because it is credible, comprehensive and globally accepted. AMEA believes that this definition will guide interactions between farmer organizations and other stakeholders, and it will lead to a more effective and sustainable development of professional farmer organizations. The definition will answer farmer organizations' needs for accessing market opportunities and for better alignment between parties they work with.

Participate in IWA for professional farmer organizations

Feeding the world in the future requires that farmers thrive. A consensus based definition of a professional farmer organization will provide market actors, capacity builders, investors, donors, commodity certification schemes and regulators with a common language and understanding around characteristics of farmer organizations and needs for improvement. Stakeholders are invited to participate in the development of this definition.

ISO recently approved the proposal for an IWA (International Workshop Agreement) for professional farmer organizations. AMEA (Agribusiness Market Ecosystem Alliance) approached the Dutch standardization institute NEN to facilitate the development of this IWA.

Common language

Alan Johnson chair of the AMEA board and senior operations officer at IFC explains the importance of this IWA: "Reaching an IWA on what constitutes a professional farmer organization will be a huge step forward for all stakeholders working in agribusiness in emerging markets. The IWA helps create a common language for all of us supporting the transition of smallholder farming from semi-subsistence to farming as a business"

All parties concerned

NEN is facilitating the development of the IWA. The recognized development process will assure that the IWA includes perspectives from all parties concerned and is based on consensus. Independent chair of the IWA-committee, Joanne Sonenshine, highlights the importance of the multi-stakeholder process: "Coming together as diverse stakeholders to support the future of farming by ensuring fair and equitable access to finance, markets and investment is critical now more than ever. Developing a mutually agreed-upon and internationally recognized definition for professionalization in the agricultural sector, as is the case in many other working environments, will allow for more efficient, collaborative and impactful engagement among the populations that need investment most."
