ANSI Offers IEC Commented Redline Version on Household and Similar Electrical Appliances

ANSI – the U.S. member body to the International Electrotechnical Commission (IEC) via its U.S. National Committee (USNC) – announced last week the availability of a new IEC value-added product. The Commented Redline Version (CMV) IEC 60335-2-24:2020, Household and similar electrical appliances – Safety – Part 2-24: particular requirements for refrigerating appliances, is available on the ANSI Webstore and Standards Connect.

Workcred and National Governors Association Publish "Understanding Quality: The Role of States in Supporting Quality Non-Degree Credentials" Brief

The brief provides several recommendations for state policymakers to consider as they recognize and support quality credentials for people re-entering or upskilling in the workforce. Workcred partnered with NGA to develop guidance for how states can identify which credentials meet quality thresholds and are likely to empower workers amid the COVID-19 pandemic.

ANAB Approved for New Hampshire Environmental Laboratory Accreditation Program

ANSI National Accreditation Board (ANAB), a wholly owned subsidiary of ANSI, has been approved to conduct on-site accreditation assessments on behalf of the New Hampshire Environmental Laboratory Accreditation Program (NH ELAP). The NH ELAP provides accreditation to environmental laboratories both within and outside New Hampshire to ensure the methods employed by those laboratories achieve sufficiently accurate, precise, and consistent results of tests, analyses, and measurements.

AI Explainability: Submit Feedback on New NIST Report

In an effort to help develop trustworthy AI systems, the National Institute of Standards

and Technology requests feedback on a draft publication report on AI explainability. ANSI encourages relevant stakeholders to respond by the **October 15, 2020**, deadline.


