The Healthcare Information Technology Standards Panel (HITSP) announces the release of the following updated and new Interoperability Specifications and related constructs for Panel approval at the December 18, 2008, Panel meeting:

- Biosurveillance Interoperability Specification (IS02) and referenced constructs
- Consumer Empowerment and Access to Clinical Information via Networks Interoperability Specification (IS03) and referenced constructs
- Emergency Responder Electronic Health Record Interoperability Specification (IS04) and referenced constructs
- Consumer Empowerment and Access to Clinical Information via Media Interoperability Specification (IS05) and referenced constructs
- Personalized Healthcare Interoperability Specification (IS08) and referenced constructs
- Consultations and Transfers of Care Interoperability Specification (IS09) and referenced constructs
- Immunizations and Response Management Interoperability Specification (IS10) and referenced constructs
- Public Health Case Reporting Interoperability Specification (IS11) and referenced constructs
- Patient-Provider Secure Messaging Interoperability Specification (IS12) and referenced constructs
- Remote Monitoring Interoperability Specification (IS77) and referenced constructs

The HITSP Technical Committees have edited the HITSP Interoperability Specifications and related constructs to address the comments received during the September 29<sup>th</sup> through October 24<sup>th</sup>, 2008, public review and comment period. Additionally, other edits that are of a minor and technical nature have been applied to the HITSP Interoperability Specifications and constructs as well.

HITSP members will be asked to approve these documents at the December 18, 2008 Panel meeting. The documents are accessible through [www.hitsp.org](http://www.hitsp.org).
