Decisions taken at SMB meeting 169, held virtually on 2020-11-09/10

SMB Decision 169/1 – Revised SMB agenda

SMB approved the revised agenda as amended and given in document SMB/7117B/DA.

SMB Decision 169/2 – TC/SC/SyC reports and SBPs

SMB, by consent:

- approved 10 reports, including SBPs, from TC/SC/SyCs, listed in Annex A of the decision list; and
- expressed appreciation to the Chairs and Secretaries of all the TC/SC/SyCs for the reports submitted.

Comments made by SMB members during the comment/approval process have been submitted directly to the TC/SC/SyCs concerned.

SMB Decision 169/3 – ahG 76 Masterplan Implementation – New ways of working

SMB thanked Ivano Visintainer for presenting the work and recommendations of ahG 76 on the evaluation of new ways of working.

SMB noted that all recommendations in document SMB/7108A/RV had been approved and agreed to handle them as follows.

(Recommendations 2 to 4) On the questions of allowing fully remote plenary meetings as a general rule (beyond current allowance due to exceptional COVID situation), examining the impact of such use on the current approval processes, and encouraging TC/SC/SyCs to make more use of such fully virtual meetings, SMB postponed any decision until ahG 88 submits its final report. In light of the continuing pandemic, SMB encouraged TC/SC/SyCs and all other relevant groups to keep making use of virtual meetings whenever appropriate to avoid delay in their work.

(Recommendation 5) SMB asked Central Office to start a pilot project applying agile methodology to the drafting period of a WG of a selected TC/SC/SyC. Central Office is further asked to consider securing external support to steer and advise the pilot project. The pilot should consider a linkage to the Online Authoring Reference Group and what they are learning.

(Recommendation 6) On the topic of agile methodology, SMB asked the newly created ahG 89 (Review of standards development process) to consider the comments made by SMB members.

(Recommendation 7) Regarding the TA procedure, SMB agreed to wait for TCs to express their interest and will decide on a case by case basis.

(Recommendation 8) SMB asked Central Office to investigate existing initiatives on open source and standardization within other groups and organizations and report back at SMB meeting 171 in July 2021.

SMB Decision 169/4 – ahG 86 – Setup of SG 12 under the revised scope

Following the recommendations made by ahG 86 in its final report, SMB approved to rename SG 12 as *Digital Transformation and Systems Approach* and revise its scope as follows:

- Define the aspects of Digital Transformation that are relevant to the IEC and its standardization activities.
- Develop a Digital Transformation methodology for international standardization.
- Act as Digital Transformation and Systems Approach competence centres within the IEC and provide associated expertise and advisory services to all IEC Committees.
- Identify emerging trends, technologies and practices needed for the development, delivery and use of IEC's work.
- Provide a platform for relevant discussion and collaboration with internal and external participation.
- Coordinate IEC's activities with those of external entities (e.g. ISO, ITU).

SMB will review the scope and structure of SG 12 once Council Board activities towards an IEC wide Digital Transformation strategy are started.

Due to the importance and complexity of the topic, SMB agreed to allow a wide participation in the renewed SG 12. SMB also encouraged participation from CAB and MSB in SG 12 and collaboration with partner organizations.

SMB appointed Ralph Sporer as the new SG 12 Convenor and thanked Tony Zertuche for his work.

SMB Decision 169/5 – ahG 86 – Disbanding of SRG

As activities pertaining to the Systems Resource Group (SRG) and the Systems Approach in general will be taken over by the Methodology Group of SG 12, SMB disbanded the SRG.

SMB thanked the Convenor and the members of the SRG for their work on the Systems Approach across the IEC.

SMB Decision 169/6 – ahG 86 – Disbanding of ahG 86

SMB thanked ahG 86 and its Convenors for the work done and disbanded it.

SMB Decision 169/7 – SG 11 *Hot Topic Radar*

SMB thanked Emmanuel Petit for his update on the work of SG 11.

SMB requested SG 11 to seek and receive feedback from TC/SC/SyCs, NCs, and other relevant IEC groups on the hot topics listed by SG 11 and to ask the TC/SC/SyCs and NCs to propose necessary standardization activities. SG 11 is also asked to report on their experience with engaging with the above-mentioned groups.

SMB further asked SG 11 to make its reports available to TC/SC/SyCs, NCs, and other relevant groups.

SMB requested SG 11 to develop recommendations on prioritized hot topics by SMB meeting 171 in July 2021.

SMB Decision 169/8 – ahG 89 *Review of standards development process*

SMB set up ahG 89, *Review of standards development process*, with the following scope:

- Review the IEC standards development process taking on board the experience from other organizations by reviewing existing initiatives (e.g. ISO Virtual Standards Development Process, CENELEC Flexible Standards Development Process, and others).
- Identify recommendations for change along with the benefits of the change as well as ideas to measure and monitor them.
- Seek inputs from TC/SC/SyCs and NCs.
- Identify bottlenecks, pain points, external constraints, and capacity development needs.
- Develop and explore methods on how to achieve change.
- Coordinate with other relevant groups like SG 12/TF 1, Online Authoring Reference Group, and Central Office IT Division.

SMB requested ahG 89 to provide its final report at SMB meeting 172 in October 2021.

SMB Decision 169/9 – ahG 90 *Prioritization of SMB work and performance/success measurement of technical work*

SMB set up ahG 90, *Prioritization of SMB work and performance/success measurement of technical work*, with the following scope:

- Review the link of SMB objectives to the IEC Masterplan Implementation Plan by leveraging the experience of ahG 76 and liaising with the Council Board Task Force on Masterplan Implementation where appropriate.
- Develop a procedure to prioritize and facilitate the SMB work (e.g. work plan, annual action plans).
- Define the meaning and the process to measure success and performance of SMB and TC/SC/SyC work, including corresponding metrics.
- Provide initial draft work plan/action plan and success/performance measures that are applicable to the ongoing SMB and technical work.

SMB requested ahG 90 to provide its final report at SMB meeting 171 in July 2021.

SMB Decision 169/10 – Remote participation and COVID related activities

SMB thanked Pierre Sebellin for providing an update of the Standardization Division activities, in particular those related to remote participation and the impact of the COVID situation on the technical work.

As shown by the data there has been no significant delay in the standards development work. SMB expressed appreciation to the global IEC community and its volunteers who are committed to continue standards development through the ongoing pandemic.

SMB Decision 169/11 – IEC Governance Review Task Force

SMB thanked Philippe Metzger for his update on the work of the Governance Review Task Force. SMB noted with satisfaction that inputs and feedback provided during the August 2020 meeting had been taken into account by the Task Force.

SMB Decision 169/12 – CB Task Force on Masterplan Implementation

SMB thanked Jo Cops for providing an overview of the mandate of the Council Board Task Force on Masterplan Implementation and welcomed the opportunity to provide feedback through ahG 76.

SMB Decision 169/13 – ISO/TMB

SMB thanked Sauw Kook Choy for providing an update on ISO activities and looks forward to continuing the fruitful collaboration with ISO/TMB.

SMB Decision 169/14 – SMB/TMB Joint Task Force on JTC 1

SMB thanked the SMB/TMB Joint Task Force on JTC 1 for its interim report and noted that the request for a time extension until February 2021 has been approved in document SMB/7109A/RV. SMB therefore looks forward to receiving the final report of the Joint Task Force for consideration at SMB meeting 170 in February 2021.
