Decisions taken at SMB meeting 167, held on 2020-02-12 in New Delhi, India

SMB Decision 167/1 – Revised SMB agenda

SMB approved the revised agenda as amended and given in document SMB/6900B/DA, with the re-arrangement of several of the items to accommodate the logistics of the day.

SMB Decision 167/2 – TC/SC reports and SBPs

SMB, by consent:

- approved 51 reports, including SBPs, from TC/SCs, listed in Annex A of the decision list; and
- expressed appreciation to the Chairs and Secretaries of all the TC/SCs for the reports submitted.

Comments made by SMB members during the comment/approval process have been submitted directly to the TC/SCs concerned.

SMB Decision 167/3 – Follow-up to decisions from previous SMB meetings

SMB noted with satisfaction that nearly all due follow-up from previous meetings had now been closed. The open issues are listed in document SMB/6959/INF.

SMB Decision 167/4 – ahG 76 *Masterplan Implementation*

SMB noted the progress made on the Implementation Plan.

SMB thanked Ivano Visintainer for his presentation on new ways of working and Tony Capel for providing an update on machine readable standards.

SMB Decision 167/5 – Nomination process in Advisory Committees

SMB decided that more than one TC/SC/SyC representative per Advisory Committee should be the exception and will require a justification. The QP will indicate if more than one TC/SC/SyC representative is proposed and provide the justification.

SMB further asked Advisory Committees to issue calls for National Committee experts to all National Committees once such a position becomes vacant.

SMB Decision 167/6 – Digital Transformation

SMB set up ahG 86, *Future of Digital Transformation including system approaches*, with the following scope:

- Recommending SMB a vision to deal with Digital Transformation, including systems related activities and recommendations of the MSB white paper on semantic interoperability.
- Recommending SMB the most appropriate scope and structure to deal with Digital Transformation, including systems related activities and recommendations of the MSB white paper on semantic interoperability.
- Evaluating the needs for coordination on requirements for IT tools as well as methods and governance for using these tools, including those that are already developed.
- Recommending outreach approaches to stakeholders, including TC/SC/SyCs.
- Coordinating closely with other initiatives at partner organizations (e.g. ISO).

SMB requested ahG 86 to provide an interim report on a draft vision statement at SMB meeting 168 in June 2020 and its final report at SMB meeting 169 in October 2020.

SMB Decision 167/7 – Systems Resource Group (SRG)

SMB decided to defer the discussion on the future of the SRG until the work of ahG 86 is completed.

SMB Decision 167/8 – SG 13 *Working with consortia*

SMB confirmed that Recommendation 1 from SG 13 on the TC 113 pilot project, allowing TC/SC/SyC Officers to invite representatives of candidate liaison organizations to attend selected meetings for a period not exceeding 18 months, had not been approved.

SMB acknowledged that the current provision in sub-clause 1.12.2 of the ISO/IEC Directives Part 1, allowing a Convenor to invite a specific guest to participate in a Working Group meeting, is sufficient but requested DMT to incorporate a limit of 3 consecutive meetings.

SMB also noted that Recommendation 2 from SG 13 on the TC 113 pilot project, allowing TC/SC/SyC Officers to invite research guests for an extended period of time to participate and contribute to research projects, had been approved. SMB further encouraged National Committees to establish a research/academic membership status to support such research projects.

SMB Decision 167/9 – Set up new PC on *Operation of electrical installations*

SMB noted that the proposal for a new PC, *Operation of electrical installations*, had been approved by the National Committees, and set up PC 128 with the following initial scope:

Standardization in the field of broad (general) principles of operation of electrical installations. These operating instructions are intended to ensure that all operation of and work activity on, with, or near electrical installations can be carried out safely. These are electrical installations operating at voltage levels from and including extra-low voltage up to and including high voltage. These electrical installations are designed for the generation, transmission, conversion, distribution and use of electrical power. Some of these electrical installations are permanent and fixed, such as a distribution installation in a factory or office complex, others are temporary, such as on construction sites and others are mobile or capable of being moved either whilst energised or whilst not energised nor charged.

SMB assigned the secretariat of PC 128 to France.

Comments made during the ballot process are referred to PC 128 for resolution at its first meeting.

SMB Decision 167/10 – TC 8 consultation on new SC on *Network management*

SMB noted that the P-members of TC 8 had approved the creation of a new SC on *Network management*. Establishing the new SC was subsequently approved by SMB.

SMB therefore ratified the establishment of SC 8C, *Network management*, and assigned its secretariat to China.

Comments made during the ballot process are referred to SC 8C for resolution at its first meeting.

SMB Decision 167/11 – SyC *Communication Technologies and Architectures*

SMB noted that the nomination of Yun Chao Hu as Chair of the new SyC on *Communication Technologies and Architectures* had been approved, and set up the SyC with the following initial scope:

- *Facilitate and advise in the domain of communication technologies and architectures to advance and harmonize communication technology related activities in the IEC according to clause 2 in AC/22/2017.*
- *Facilitate outreach and influence the work on communication technologies and architectures with other standards development organizations and industry consortia, in collaboration with SG 13.*

The secretariat of the new SyC will be held by Central Office.

Comments made during the ballot process, as well as the proposal from France and Germany to appoint a Vice-Chair, are referred to the SyC for resolution at its first meeting.

SMB Decision 167/12 – TC 77 presentation

SMB thanked Klaus-Peter Bretz, Secretary of TC 77, for his presentation and noted the impact of new technology developments and applications on the electromagnetic environment.

SMB also agreed on the importance of effective coordination between TC 77, ACEC and CISPR.

SMB Decision 167/13 – TC 122 presentation

SMB thanked Eiichi Zaima, Secretary of TC 122, for his presentation and acknowledged the importance of UHV technology to meet the increase in electricity demand worldwide.

SMB also welcomed close interactions with ACTAD as well as the ongoing collaboration with CIGRE.

SMB Decision 167/14 – JTC 1/SC 7 presentation

SMB thanked Sundeep Oberoi, Chair of JTC 1/SC 7, for his comprehensive presentation of software and systems engineering standardization activities in JTC 1 and acknowledged the progress made and information provided on machine readable standards and systems engineering.

SMB also looked forward to increasing collaboration with JTC 1/SC 7.

SMB further noted the challenges identified by JTC 1/SC 7 regarding competition and participation.

SMB Decision 167/15 – TCs not submitting reports within 4 weeks of their meeting

SMB noted that TC 5 (CN), TC 17 (SE) including SCs, TC 22 (CH), TC 42 (CA) and TC 46 (US) including SCs, had failed to submit their reports (RSMB) on time and invited the National Committees holding the secretariats to investigate.

SMB Decision 167/16 – Annual review of TC/SC statistics

SMB commended TC 57 for their efforts to improve programme management through an “effectiveness programme” and looked forward to receiving further information and feedback about this programme.

SMB Decision 167/17 – Discussion on the future of the CDD (Common Data Dictionary)

SMB noted the importance of the CDD and urged Central Office, the new Reference Group on Database Standards and other relevant groups to speed up the modernization of the CDD.

SMB further requested information on the timeline of activities on database development.

SMB Decision 167/18 – Transparency in technical procedures

SMB agreed with the importance of transparency in technical procedures and the execution of those procedures and acknowledged the need to handle any possible issue in a transparent way.

SMB Decision 167/19 – Translation time at CDV stage

Following Decision 158/14, SMB decided to leave the existing process unchanged, allowing 6 weeks for translation at the CDV stage.

SMB urged National Committees translating documents to explore further opportunities to add flexibility and reduce translation time and will keep monitoring the status.

SMB further noted the importance of reviewing the whole development process with the goal of higher efficiency and timeliness.

SMB Decision 167/20 – DMT membership

SMB decided to increase the number of DMT members from 12 to 14 in order to cope with the significant amount of work related to the revision of the ISO/IEC Directives.

SMB noted that the current call for selecting two DMT members among four candidates was ongoing as per document SMB/6969/QP, and further approved the nomination as DMT members of the four candidates (Karen Batt, Myounghyun Shim, Ivano Visintainer, Liang Zhang).

SMB Decision 167/21 – JDMT Recommendation 19/201912 – Horizontal Deliverables/Publications

SMB noted that JDMT recommendation 19/201912 on horizontal deliverables/publications had been approved.

SMB therefore agreed to establish a joint SMB/TMB group with the task to develop a proposal for a common process using IEC Guide 108 as an input. SMB asked its secretariat to engage with the TMB secretariat to set up this group and include the following SMB representatives in its membership: CA, FR, NL, UK, US.

SMB requested the joint SMB/TMB group to report back at SMB meeting 169 in October 2020.

SMB Decision 167/22 – SAG – Free availability of standards from SyCs

SMB noted that, following Decision 165/18, the Sales Advisory Group (SAG) provided recommendations for dealing with the issue of free availability of some SyC deliverables.

SMB further asked SyC Smart Energy to provide a feedback to SAG on their recommendations and implement them.

SMB Decision 167/23 – ISO/TMB

SMB thanked Antoine Morin for his update on ISO activities and appreciated the very good cooperation between IEC and ISO.
