## U.S.-Indo-Pacific Standards and Technology Cooperation Program

Join these two workshops on Indonesia's digital healthcare transformation and best practices in a regional and global context. Participants will engage with key Indonesian and U.S. regulators and industry experts to share technical advice and best practices for implementing policies that advance healthcare standards, procurement, and innovation goals. **Participants may attend both days by registering once.**

### BACKGROUND

Innovation and digitalization in healthcare will require regulators and practitioners to respond quickly to new developments across the sector. How Indonesia responds to these innovations will directly impact healthcare availability, along with other applications in healthcare technologies.

These workshops, co-organized by the Indonesia Ministry of Health, will allow panelists to share insights into domestic and international regulatory considerations, highlight industry experiences, economic opportunities, and promote standards harmonization. The objectives are to:

#### Day 1:

- Detail the landscape of Indonesia's digital transformation in healthcare.
- Share insights on the role of inclusive standards and procurement practices in fostering and promoting innovation.

#### Day 2:

- Discuss the concept and design of regulatory sandbox in adapting to fast-changing technologies and in driving innovation.
- Introduce participants to new technologies and innovation in the healthcare sector.

Key participants will include Indonesian and the U.S. government officials, industry experts, as well as other key stakeholders.
