



# **STANDARDS ALLIANCE: PHASE 2**

## BW+ (Bottled Water Plus) - Bottled Water Certification Scheme for Senegal

## **OVERVIEW**

The Senegalese standardization body, Association Sénégalaise de Normalisation (ASN), has requested the Standards Alliance: Phase 2 support in the development of a Bottled Water Certification scheme according to the West Africa Standard ECOSTAND 022, which Senegal has adopted. ECOSTAND 022 concerns quality, packaging, labelling, sampling and testing requirements for packaged natural mineral waters intended for sale as foodstuff. ASN operates under the supervision of the Ministry of Industrial Development and Small and Medium Industries (SMIs), with a mission to promote the development of national standards, disseminate information, raise awareness, and provide training to economic actors in Senegal, including stakeholders such as manufacturers, distributors, consumers, and administration agents.

NSF's Bottled Water Certification program is the only accredited product certification program that offers analysis for bottled water, including microbiological, chemical, and radiological analyses in accordance with national and international regulations, such as FDA, EPA, EU, ANVISA, BIS and China Natural Mineral Water. Additionally, NSF has a Registration available for the manufacturing process. The project will include both a product certification with an analytical component and support and training for auditing and Good Manufacturing (GMP) practices.

This project will be implemented by NSF International through USAID's public-private partnership with the American National Standards Institute (ANSI), the Standards Alliance: Phase 2.

### **OBJECTIVES**

ASN is ISO 17065 accredited, however their scope does not currently include bottled water or ECOSTAND 022. Therefore, the project shall include support to expand the scope of ISO 17065 to include the requirement of the standard and. build the capacity within the bottled water certification stakeholders, including, but not limited to ASN certification department staff, auditors, laboratories and other from the key government ministries and the private sector. ASN will be instrumental in assisting with identifying and conducting outreach to these groups.

With the aim to build a robust certification program against the ECOSTAND 022, NSF will conduct virtual trainings in French to sensitize and educate stakeholders on the value of standards and conformity assessment, technical capacity strengthening, and highlight the need for regulation to drive manufacturer compliance to ECOSTAND 022. Technical strengthening would included auditor workshops on Good Manufacturing Practices, Good Hygienic Practices, and training related to product sampling methodologies.

A Bottled Water Certification program will not only advance public health regarding drinking water safety in-country, advancing Sustainable Development Goal (SDG) 6: Clean Water and Sanitation and SDG 3: Good Health and Wellbeing, but will greatly improve marketability for the manufacturers within Western Africa regions, and possibly more globally, particularly where interoperability opportunities across national regulatory regimes exist. With this, USAID, ANSI, ASN and NSF contribute to progress with respect to the finance, capacity building and trade targets of SDG 17: Partnerships for the Goals.

Developing ASN's capacity to provide testing and certification to ECOSTAND 022 will improve the bottled water market both within Senegal and in the global market.

## ACTIVITIES

The project will occur over 1.5 years (Q2 2024-Q2 2025) with three activity phases:

- Project Stage 1: expand the scope of the ISO 17065 to include the requirement of the ECOSTAND 22 standard
- Project Stage 2: build the capacity within the bottled water certification stakeholders, including, but not limited to ASN certification department staff, auditors, laboratories and other from the key government ministries and the private sector.
- Project Stage 3: provide training on auditing, laboratory sampling methods, ISO 17065, and Certification
