→ NAVIGATING A NEW INDUSTRY STANDARD

REACH, the European regulation on chemicals and their safe use (EC 1907/2006) became effective in June 2007.

Under REACH, substances must be registered with the European Chemical Agency (ECHA) if they are manufactured or imported in quantities of 1 tonne or more per year. REACH accommodates for substances that have been manufactured or imported in the last 15 years with a pre-registration procedure. Companies can pre-register their existing substances with ECHA. The goal is to identify other potential registrants with the same substance. For each existing substance, a Substance Information Exchange Forum (SIEF) brings together all manufacturers and importers who have pre-registered the same substance. This SIEF process is mandatory and comes with the obligation to share animal study data and to submit a joint registration dossier.

→ ENABLING YOUR REACH



While REACH sets standards and requirements, the road to compliance must be paved by the industry. Specifically, ECHA will not be involved in setting up the collaboration that the SIEF process requires. To help companies with the SIEF process, CEFIC and the German (VCI), French (UIC), Italian (Federchimica), British (CIA) and Spanish (FEIQUE) Chemical Associations founded ReachLink SA (Sociéte Anonyme). ReachLink's mission is to provide the support that will facilitate your data sharing in the REACH registration process. With SIEFreach, ReachLink connects you with other potential registrants to accomplish REACH registration compliance.

SIEFreach is an IT platform that enables and manages your SIEF communication, collaboration and preparation of joint submission processes. REACH compliance can get complicated. SIEFreach brings ease of use and efficiency to the SIEF process:


