

**CAB Profile Response Form**

StandardsPortal ([www.standardsportal.org](http://www.standardsportal.org)) is an online resource designed to facilitate more open and efficient trade between the U.S. and other countries in the area of standards, conformity assessment, and technical regulations. The Portal currently houses profiles of U.S.-based Standards Developing Organizations (SDOs), Trade Associations, and Government Agencies, and is now collecting organizational profiles from Conformity Assessment Bodies to add to the current repository of key actors in the U.S. system.
