INTRODUCTION

The Standards Alliance is a public-private partnership between the American National Standards Institute (ANSI) and USAID designed to assist developing countries in effectively implementing their commitments under the WTO's Technical Barriers to Trade (TBT) agreement.

The main objectives of the overall Standards Alliance program includes increased understanding of WTO TBT principles, encourage transparency in the development and alteration of technical regulations, and improve implementation of the TBT Agreement's Code of Good Practice for the preparation, adoption and application of standards, with the larger goal of promoting trade and economic development.

The Standards Alliance received various forms of input that contributed to the Year One Work Plan for the Southern African Development Community (SADC). Lesotho, Malawi and Zambia submitted applications to participate in the Standards Alliance that identified areas for assistance. In November 2013, ANSI carried out its joint assessment for the region. ANSI traveled to South Africa and met with SADC Cooperation in Standards (SADCSTAN), the SADC Standardization, Quality Assurance, Accreditation and Metrology (SADCSQAM) body responsible for coordinating standardization activities and services in the region. ANSI also met with the South African Department of Trade and Industry (DTI) and the South African Bureau of Standards (SABS), among other organizations. A summary of the joint assessment is available upon request. Both before and after the joint assessment, ANSI communicated with ANSI members regarding their interest in supporting the project's engagement with the region.

The Standards Alliance recognizes the need to engage SADC in such a way that responds to both the unique and shared needs of the countries within the region. As such, engagement will proceed through multiple channels. The Standards Alliance will engage SADCSQAM bodies in an effort to respond to regional priorities. Additionally, the project will engage individual, or numerous countries within SADC, on issues best addressed at the national level. In addition to Lesotho, Malawi and Zambia, the project anticipates working with other countries within the region.

The Standards Alliance looks forward to carrying out the SADC work plan in cooperation with USAID's Southern African Trade Hub (SATH). SATH will take the lead on several activities, as indicated.

The Standards Alliance has set the following as goals for its engagement with SADC:

- 1. More effective National Notification Authorities (NNAs) and Enquiry Points (EPs).
- 2. Enhanced standards development process, especially through increased participation in standards activities.
- 3. Improved interagency coordination on technical regulations.
- 4. Established relationships between US SDOs, certification and accreditation bodies and SADC national/regional standards bodies.

These goals, and the activities listed below, are subject to change as our understanding of needs and capacities deepen.
